ADOPTION AGREEMENT - TERMS OF ADOPTION

1. You agree to adopt the above stated Cesky Terrier \_\_male \_\_female with the call name of "\_\_\_\_\_."
2. If the Cesky Terrier has been altered/spayed by Rescue, you agree to donate \$\_\_\_\_\_ to the National Cesky Terrier Club Of America Rescue for this service.
3. Cesky Terriers are typically affectionate and friendly, and Rescue will not place a dog known to have an unsound temperament. However, no one can predict how any dog will react in a given situation, especially without complete knowledge of its life experiences. Therefore, adoptive owners are strongly urged to exercise prudence and caution in introducing an adoptive Cesky into a new situation until the Cesky has become fully adjusted to its new environment and the adoptive owner has had an opportunity to become familiar with that Cesky Terrier's personality.
4. No Cesky Terrier will be placed in a new home which does not provide a fenced yard, except for apartment dwellers. A Cesky must never be allowed to run loose. It should always carry identifying tags or be tattooed with an identifying name or number, or have a microchip implant. Apartment dwellers must agree to always walk the dog on a leash. Because Cesky Terriers are bred as Earthdogs, they will run, hunt, and dig. Basically, Cesky Terriers are best kept as housedogs in close companionship with their families. They should also be in a home where they will be sleeping in the home and not left outdoors at night.
5. Adoptive owners must be prepared to demonstrate their ability and willingness to provide proper food, medical care, and a loving, safe, healthy and clean environment for the adoptive Cesky. Even if the dog has already had a basic obedience course, we urge a "refresher" course to establish respect and a close rapport more rapidly between the dog and owner. Always be sure that the trainer is familiar with the Cesky temperament.
6. The ownership and responsibility for the adopted Cesky Terrier belongs solely to the adoptive owners. However, if for some valid reason, the adoption does not work to the advantage of the new owner and the dog, the National Cesky Terrier Club of America Rescue must be contacted and given the option of reacquiring the Cesky before any further placement. The adoptive owner shall not transfer ownership of the Cesky unless the National Cesky Terrier Club of America elects not to exercise this option within 14 days.
7. Inasmuch as is practical, each prospective adoptive home will be visited by an National Cesky Terrier Club of America Rescue member/representative to evaluate it's qualifications as an adoptive home.
8. The placement of a male Cesky Terrier in a home in which another male dog of any breed lives will be considered only in the most exceptional cases, and this type of placement is strongly discouraged. A follow-up

visit and supportive advice by a participating National Cesky Terrier Club of America member/representative will be strongly urged following placement of a Cesky Terrier through the Rescue.

TERMS OF ADOPTION (continued)

9. The National Cesky Terrier Club of America Rescue makes no representations or warranties regarding the temperament or physical condition of any adoptive Cesky Terrier. All warranties, including implied warranties of the merchantability and fitness for a particular purpose, where they are applicable, are hereby disclaimed.

10. The National Cesky Terrier Club of America Rescue shall not be responsible for any bodily injuries or property damage caused by any adopted Cesky Terrier or by the actions of its adoptive owners. The adoptive owner hereby specifically assumes sole responsibility for, and agrees to hold the National Cesky Terrier Club of America Rescue harmless from, any and all loss and expenses (including legal fees) by reason of liability imposed by law upon the National Cesky Terrier Club of America Rescue, or any of it's officers and members because of bodily injuries or death to any person or persons including the adoptive owners, or any damage to property arising out of or in consequence of the placement of the Cesky Terrier, howsoever such injuries, death or damage to property may be caused, whether or not the same may have been caused, or may be alleged to have been accused, by negligence of the aforementioned parties or any of their employees, agents or members, or any other person.
